Release and Waiver of Liability Indemnity Agreement

In consideration of allowing me to participate in the hunting related event and/or activities hosted in full or in part by Lester Vanhill.

I Warranty To You That:

- 1) I am familiar with the risk of serious injury and death which any participant in this hunting event must assume and
- 2) I believe that I am physically, mentally and emotionally able and capable to participate in this hunting event and that my equipment is mechanically fit for my use during this hunting event and
- 3) I understand that all applicable rules & laws for participation must be followed at all times, the sole responsibility for personal safety remains with me, and
- 4) I will immediately remove myself from participation, if at any time I sense or observe any unusual hazard or unsafe condition or if I feel that I have experienced any deterioration in my physical, emotional or mental fitness for continued participation in this hunting event.

I understand and agree, on behalf of myself, my heirs, assigns, personal representatives and next of kin, that my participation in this hunting event and execution of this document constitutes:

5) an unqualified assumption of all risk associated in participating in this hunting event by me even if arising from negligence, or gross negligence, including any compounding or aggravation of injuries caused by negligent rescue operations or procedure or the hunting event organizer and any person associated therewith or participating therein and,

- 6) A full and final release and waiver of liability of the hunting event organizer and all persons and organizations associated with it and the hunting event including without, limiting the generality of the foregoing, its officers, directors, officials, agents and/or employees, other participants, sponsors, advertisers, owners and/or leaser of the premises / areas / fields used to conduct this hunting event(s), sanctioning bodies, medical or rescue personal (the releases), of and from and with respect to all injury, disability, death, or loss or damage to person or property weather arising from the negligence, gross negligence, or negligent rescue of or by the foregoing , or otherwise, and
- 7) An undertaking not to sue the releasees for any loss, injury, cost or damages of any form or type howsoever caused or arising and weather directly or indirectly from my participation in the hunting event and
- 8) An agreement to indemnify and save and hold harmless the releases, and each of them from any litigation expenses, legal fees, liability, damage, award or cost, of any form or type whatsoever, they may incur due to any claim made against them or any one of them whether the claim is based on negligence, gross negligence of the releasees or otherwise.

I UNDERSTAND THAT THE RELEASEES ARE RELYING UPON MY WARRANTIES, ASSUPTIONS WAIVER AND RELEASE, UNDERTAKING AND AGREEMENT WHEN ACCEPTING MY PARTICIPATION IN THIS HUNTING EVENT.
